

ave you wondered about concealed carry when traveling? Does your Concealed Carry Permit (CPL) cover you in other states? How about Open Carry...are the laws the same everywhere? Some states have passed Constitutional Carry, which means you do not need to have a permit to carry concealed. Washington is NOT one of those states.



This official website for Washington's Attorney Genereral, <a href="https://www.atg.wa.gov/concealed-pistol-license-reciprocity">https://www.atg.wa.gov/concealed-pistol-license-reciprocity</a>, is up to date with the reciprocity laws for our state. ## **INTRODUCE YOURSELVES!**


