Board of Trustees consists of 3 members, elected to serve 3 years. The terms are staggered. The Board of Trustees is an independent body from the Board of Directors. Trustees shall conduct financial audits as necessary and required by law. The Trustees shall conduct any recall investigation, mediation and recommendation in the case of a recall of an officer or trustee, in accordance with the club By-Laws. Trustees shall act as an independent review and advisory committee and may make reports to the general membership on concerns of the Club.

President – The President is the presiding officer at all meetings of the Club and the Board of Directors. The President shall appoint all committee chairs and approve all committee members. The President may call special meetings of the membership, Board, standing or special committees, at their discretion, and is an ex-officio member of all committees. The President shall otherwise serve as the principal administrative officer and shall be the spokesperson for the Club.

Vice President – The Vice President performs the duties of the President upon the President's request or absence. The Vice President serves as a member of the Community and Charitable Activities Committee, in addition to any special requests by the President to join other committees or projects.

Secretary - The Secretary conducts the official correspondence and maintains the official records of the Club, except the financial records. The Secretary records or causes to be recorded, the minutes of all meetings of the membership and Board.

Treasurer - The Treasurer is responsible for managing the Board's review of, and action related to, the organization's financial health. The Treasurer ensures that comprehensive financial reports are made available to the Board at least quarterly and identifies opportunities to strengthen the Board's ability to carry out its fiscal responsibilities. The Treasurer is accountable for maintaining accounts and appropriate fiscal controls. The Treasurer serves as a member of the Finance and Audit Committee.

Executive Officer - Has over-all responsibility for the shooting activities of the Club and ensures that they are conducted safely and in accordance with accepted rules and procedures. The Executive Officer will co-ordinate the use of all Club facilities and is responsible for their maintenance and operation. The Executive Officer will assist the president with selection of committee chairs and members for the individual shooting disciplines and shall be a member of the Maintenance and Operations Committee.





We meet from 3 – 6 PM, 3rd Sunday of the Month.

Cost for each event is \$8 MCSA member/ \$10 non-member.

Most meetings include range time for practice in addition to the program. Bring your unloaded firearm in a box or bag, at least 50 rounds of ammunition, eye and ear protection and a brimmed hat.





MCSA Fee Increases

s considered and approved by membership in July, 2022, beginning on January 1, 2023, all event and membership rates will increase as follows:

\$10 for members

\$15 for non-members

Guest fee \$10 (each guest, each time they attend, plus a signed waiver form with their payment).

MCSA Membership Dues changes, including and increase in the volunteer hour value:

Volunteer hours value increased to \$5.25 across the board. (it was \$3.75)

Volunteer hour obligation remains the same, up to 20 hours for a Single membership and up to 30 hours for a Family membership.

MCSA Membership dues raised to:

Single Membership fees increase to \$175, discount of \$105, if 20 volunteer hours are served in the membership year, bringing the dues to \$70.

Members are only eligible for this discount as renewal payments, not as an incoming new member. (Current fees for a single are \$125 with a possible balance of \$50 if 20 volunteer hours are served by the time of their renewal.)

Family membership fees increase to \$262.50, discount of \$157.50 if 30 volunteer hours are served in the membership year, bringing the dues to \$105.

Members are only eligible for this discount as renewal payments, not as an incoming new member. (Current fees for a family are \$187.50 with a possible balance of \$75 if 30 volunteer hours are served by the time of their renewal.)

New Members will pay the non-volunteer dues amount as their first payment plus the 1-time Initiation Fee, which stays the same at \$75.


Key Card cost stays at \$20.

Membership options will no longer include the Lifetime membership category, however, we will continue to award the Lifetime achievement award once every 2 years.
